Open to all DCAL Members in good standing (paid 2008 membership dues). Eligible works include all media but must be original and produced within the last two years. No giclée prints or other reproductions allowed.

ENTRY & FEES:

Each member may enter up to two 2-dimensional wall-hung works or two 3-dimensional pieces. Each member will be guaranteed at least one piece in the show, both will be exhibited if space allows. DCAL will refuse to accept improperly prepared pieces.

REGISTRATION:

Please fill in the form to the right and bring this sheet with you when entering your work. Be prepared to sign the "Hold Harmless" agreement below.

REGISTRATION:

Please fill in the form to the right and bring this sheet with you when you enter your work. Be prepared to sign the "Hold Harmless" agreement below left.

SPECIFICATIONS:

Works must not exceed 48x72" including frame or display mount for any one piece. All 2-D work must be suitably framed with secure wire hangers (NO saw-toothed hangers). Wall-hung sculptures or fiber works must be fitted with secure hanging devices. Each piece must be labeled on the back with the name of the exhibit, artist's name, address, phone, title of piece, medium and sale price, if applicable. 3-D work must be labeled on the bottom, back or other suitable location. You may use your own labels as long as the information is the same as indicated on the label format to the right. Works that do not meet entry requirements will be rejected at the door.

CONDITIONS:

Work in all media will be accepted, with the exception of reproductions or those assembled from kits. All work must be original without instructor supervision and must have been completed within the last two years. Work that has been previously exhibited in Door County is not acceptable. All work must be dry and ready for hanging. The submission of entries shall be understood to constitute an agreement to the conditions of this prospectus. No work may be withdrawn before close of the exhibit. *Work not picked up by the artist or artist's representative on the designated days will be assessed a fee of \$10 per day until the piece(s) are retrieved. Works left unclaimed for three months will be sold and the proceeds will go to the annual fund.*
