Welcome to our beautiful Gallery. You as an ART LEAGUE member are welcome to join us. See the attached CALENDAR for times and events. At the Gallery you are a cooperative member. Each individual will have a job to do and will help attend the gallery once each month. You will have an opportunity to demonstrate your art and your demo will be well publicized.

To defray the expense of rent, there will be an EXHIBIT CHARGE of \$100-PAYABLE AT time of CHECK IN. A COMMISSION CHARGE of \$15% on your sales will be collected. You agree to exhibit the entire season.

Check in your artwork on Sat. May 17, 1-5:00 p.m., or Mon.evening, May 19, 7-9:00p.m.

Bring in your Hold Harmless Agreement. Have it filled out and have an identical label on the back or bottom of your 3- D art. Any cards, jewelry, etc. may be identified on the back of the Hold Harmless Agreement. A numbering system works well. Similarly identify your cards, jewelry or other miscellaneous small items. Bring your calendar so to identify a time to attend the gallery or do a demonstration of your work. Or to sign up for a committee.

You may have to look for a substitute to take your place due to unforeseen circumstances. But if needs be, you pay \$50 to the Art League for another artist to take your turn. Please notify the Gallery or manager if there is a change in the days for which you are responsible.

CRITERIA FOR ENTRY:

The 150 united inch rule. All wall -hung work must be original and must not exceed 150 united inches. That is width on one side plus (+) the length on one side. You need not include the frame in your measurement. Three-dimensional works should be measured as though they are boxed in. Width plus height.

All wall-hung art must have a suitable wire hanging devise.

All prints will be displayed in a print rack. They must be shrink-wrapped. If you have a rack of your own please bring it. We will also store one or two packages note cards or prints of each image in our storage room. We are in need of small display cases and small tables to display pottery, carvings. We also need card racks.

All works must be original and the work of the artist member. No kit made items.

There will be two dates, July 1 and August 19 when you may bring in replacements, remember the 150" rule. The exhibit will be re-hung.
